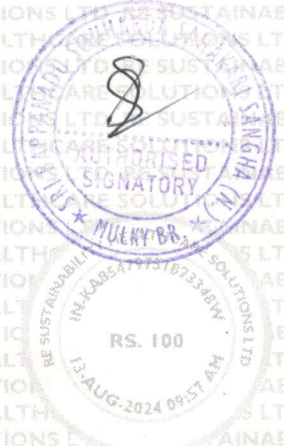
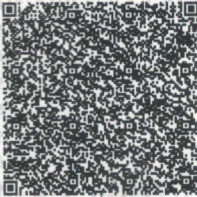

This Memorandum of Understanding is made on this 13th day of August 2024, BETWEEN

M/s. Resustainability Healthcare Solutions Ltd. having its registered office at Level 11B, Aurobindo Galazy, Hyderabad Knowledge City, Hitech City Road, Hyderabad – 500081 and having CBMWT Facility at Plot No. 47/B, Karnad Industrial Area, KIADB Mulki – 574154 Mangalore, D.K. (Dist) Hereinafter referred to as M/s. Resustainability Healthcare Solutions Ltd

AND

M/s. Father Muller Medical College & Hospital, Fr Muller Road, Kankanady, Mangalore. Hereinafter referred as M/s. Father Muller Medical College & Hospital.

- a. **M/s. Resustainability Healthcare Solutions Ltd** with consent with pollution control board having a common treatment facility for managing bio-medical waste in Dakshina Kannada district located at plot no 47-B, KIADB Industrial area, Karnad, Mulky, Mangaluru. The facility is having state of autoclave system along with shredder and Incinerator.
- b. **M/s. Father Muller Medical College & Hospital** gives its bio-medical waste properly packed in colour coded bags (in case of amputated parts the hospital should give one letter duly signed by authorized person mentioning the patient's name, age & reason for amputation) as per pollution control board regulations for treatment and final disposal to **M/s. Resustainability Healthcare Solutions Ltd** The waste should be given at one single point by the **M/s. Father Muller Medical College & Hospital** at given time of **M/s. Resustainability Healthcare Solutions Ltd**
- c. **M/s. Resustainability Healthcare Solutions Ltd** shall charge a fixed price of Rs. 2,40,000/- (Two Lakh Forty thousand) per month for Bio Medical waste disposal for the period of 3 years from **01.09.2024 to 31.08.2027** as mutually agreed between the **M/s. Resustainability Healthcare Solutions Ltd** and **M/s. Father Muller Medical College & Hospital**.
- d. The said fees can be increased in the event of increase in the rates of petrol, diesel and petroleum products and taxes levied by the Government from time to time upon notice and mutual consent of Parties.
- e. **M/s. Father Muller Medical College & Hospital**, is assuring that it shall make the payment regularly through Account payee cheque in favour of **M/s. Resustainability Healthcare Solutions Ltd** on or before 10th of every month. If there is any delay in payment by the Hospital, the Hospital shall pay interest at the rate of 18% per annum.
- f. **M/s. Father Muller Medical College & Hospital** during this period will not enter into any agreement with any other party or organization for the waste treatment and disposal.
- g. **M/s. Father Muller Medical College & Hospital** has having **1250 (One Thousand Two Hundred Fifty)** number of beds. The exact number of beds will be taken from the declaration given to the state authorities.

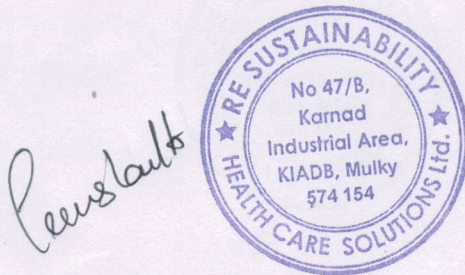

- h. **M/s. Resustainability Healthcare Solutions Ltd.** will collect bio medical waste regularly and treat the waste as per the regulations. **M/s. Resustainability Healthcare Solutions Ltd.** will not collect any waste that is not segregated or properly packed and also general garbage.
- i. **M/s. Father Muller Medical College & Hospital** if requested will supply the colour coded waste collection bags at a nominal rate mutually decided between **M/s. Resustainability Healthcare Solutions Ltd** and **Father Muller Medical College & hospital**.
- j. **M/s. Resustainability Healthcare Solutions Ltd** will issue a proof waste collection from **M/s. Father Muller Medical College & Hospital** on regular basis. This will help the individual hospital for getting compliance with the state pollution control board. The individual hospital/Nursing home can take their authorization from the pollution control board by informing the board that **M/s. Resustainability Healthcare Solutions Ltd** treats their waste, (the same has to be mentioned in the authorization form).
- k. In case of hospital/nursing home/clinics find any irregularities in collection waste, they can send a notice in writing to **M/s. Resustainability Healthcare Solutions Ltd.** for immediate action.
- l. **M/s. Resustainability Healthcare Solutions Ltd.** will maintain their plant in good condition all the time and ensure continuity of service on all the days without fail and get clearance from the Pollution Control Board as per regulations.
- m. This Memorandum of understanding is entered into on the express understanding that **M/s. Resustainability Healthcare Solutions Ltd.** will maintain and run the facilities and collect transport and treat the waste at their plant strictly in accordance with the consent of the Karnataka State Pollution Control Board and it shall be the responsibility to obtain the consent and keep the same always in force.
- n. In case of violation of any of the agreed conditions of the MOU by either side, Issue of notice may terminate this MOU one month in advance by either party for terminating their respective obligations.

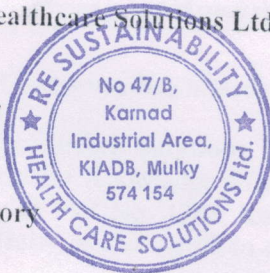
- o. This Memorandum of Understanding will remain valid for a period of 3 years commencing from **1st September 2024 to 31st August 2027**. Further Renewal may be done based on mutual consent.
- p. All the employees of M/s. Resustainability Healthcare Solutions Ltd. shall have to undergo medical examination at the time of employment and later as per the NABH Guidelines annually. Cost of medical examination shall be borne by M/s. Resustainability Healthcare Solutions Ltd. No person other than one found to be medically fit shall be employed by M/s. Resustainability Healthcare Solutions Ltd.
- q. M/s. Resustainability Healthcare Solutions Ltd. shall observe the safety precautions in the collection, segregation and disposal of biomedical waste management at Father Muller Medical College Hospital prescribed by Karnataka Pollution Control Board. Father Muller Medical College Hospital reserves the right to conduct surprise checks to ensure safe practices are followed during waste management.
- r. **M/s. Resustainability Healthcare Solutions Ltd.** is obliged to inform the Father Muller Medical College Hospital in case of untoward incidents including needle stick/ sharp injury when collecting waste from premises by its employees
- s. This MOU can be terminated from either side by giving three months' notice period.
- t. All disputes to this understanding are subject to the jurisdiction of the court in Mangalore only.

All the above points will have legal binding for a minimum period of Three years from the date of this agreement.
