<b>17.Skill development:</b>					
<p>Father Muller Medical College has well established Father Muller Simulation and Skills Centre (FMSSC). The centre has multi-professional training facility equipped with the most advanced medical simulators and skills trainers. Established in 2015 as the first functioning advanced simulation centre in Mangalore. FMSSC is committed to inculcate evidence based simulation competence into the healthcare curriculum. The centre is the first &amp; only Simulation Centre in the country to be Accredited by the International Organisation, SSH (Society for Simulation Healthcare). It is also the first medical college in Mangalore to be accredited by the American Heart Association as an authorized training centre for CPR</p>					

& ECC courses. It is also the first certified regional training centre for the JeevaRaksha Emergency courses under Rajiv Gandhi University of Health Sciences. Simulation based teaching is conducted for both under graduates and post-graduate students by using High Fidelity Patient Simulators for recreating real time clinical scenarios. Teaching session is followed by debriefing session involving guided reflective learning. Simulation based learning creates shift from traditional teacher centered learning to student centered learning. Simulated learning is useful for reflecting upon experience in clinical areas because it develops clinical reasoning and integrates theory with practice. Competencies with Psychomotor domain as per CBME curriculum are demonstrated using simulators. In addition to this, Student Surgical club organises regular programs related to surgical skills for MBBS students. MBBS students have to complete the Certifiable skills made mandatory by the statutory body as per the Competency Based Medical Education (CBME) curriculum. Skills of the students are assessed and certified by the faculty.

**18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)**

As per the statutory body (National Medical Commission) and affiliating university ie Rajiv Gandhi University of Health Sciences, the medium of instruction for MBBS, MD/MS courses is English. However, festivals of different religion and cultures like Christmas, Holi, Dussera, Onam etc are celebrated in the institution in order to inculcate cultural values among students. Ethnic day is celebrated to create awareness about the religious culture, practices and regional languages of India. Inter-batch cultural fest is organised to inculcate cultural thoughts among the students.

**19.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):**

Medical education is imparted to the students as per the curriculum prescribed by the statutory body (National Medical Commission) and affiliating university (Rajiv Gandhi University of Health Sciences) for both under-graduate and post-graduate programs. New MBBS curriculum ie CBME curriculum is mainly focussed on outcome based medical education. Competency based Medical Education provides an effective outcome-based strategy where various domains of teaching including teaching learning methods and assessment form the framework of competencies.

**20.Distance education/online education:**

Father Muller Medical College is an institution affiliated to Rajiv Gandhi University of Health Sciences, Bangalore and recognised by the statutory body i.e National Medical Commission. Institution

offers under-graduate and post-graduate medical education. As per the SRA and affiliating university, there is no provision for the institute to offer distance education/ online education. However, institution encourages faculty and post-graduate students to enrol in the MOOCs offered by NPTEL, SWAYAM and other agencies. Online courses completed by the faculty is considered for Annual Performance Appraisal.

It is affiliated to Rajiv Gandhi University of Health Sciences, Bangalore and is recognized by the National Medical Commission. Institution follows the curriculum prescribed by the statutory body. Teaching-learning activities are conducted as per the university guidelines. Link to the university website is provided in the institutional website through which faculty, student and other stakeholders can access the Curriculum.</p> <p>Teaching - learning methods are employed to deliver the curriculum effectively. The various methods used are Didactic Lecture, Small group discussion, Self directed learning sessions, Simulation based learning, Seminar, Case discussion, bed side teaching, integrated teaching, community teaching etc.</p> <p>Assessment: Students are continuously assessed by formative and summative assessments. Qualifying examination is carried out as per the university guidelines. In addition to this, assessment of students is also done during clinical posting, after completion of each topic, case discussion, seminar presentation etc.</p> <p>Curriculum committee, Curriculum sub-committee, Medical education unit are mainly involved in the curriculum implementation.</p>

Cross-cutting issues relevant to gender, environment and sustainability, human values, health determinants, Right to Health and emerging demographic issues and Professional Ethics are integrated into the curriculum by the institution. Sessions on Gender equality are conducted for MBBS students during Foundation course and Post-graduates during course orientation program. NSS unit is involved in creating awareness among students about environment by conducting activities under Vanamahotsava and Swacchh Bharat mission. Eco friendly measures are employed by the institution like planting of new saplings, effluent treatment and recycling system, ban on tobacco products, ban on plastic use etc. AETCOM modules for MBBS students include sessions on Professional ethics and Human values. Concept of Right to Health and Emerging Demographic issues are addressed during Community Medicine posting. Students also deliver awareness programs on Right to health and health issues to the public in rural health centers. Orientation program conducted for the newly joined postgraduates includes sessions on duties & responsibilities, introduction to research, establishing rapport between Patient and Doctor, Bioethics and Human relationship, Communication in Medicine etc.

- **Experiential learning:** Students learn by doing in simulated scenario in the Simulation centre. Surgical Training for post Graduates using Goat Eye, Live Viewing / Video Recording of Live Surgeries etc are used.
- **Inter-departmental activities:** Seminar, case presentation etc are regularly conducted.
- **Integrated teaching:** Integration in the form of nesting, sharing, linker cases were conducted for MBBS students.
- **Early clinical exposure:** For first year MBBS students to make them to understand clinical application of basic science subjects.
- **Student centered teaching:** Case based learning, role play, self-directed learning, Basic airway training and vascular access training, Case review etc.
- **Outbreak investigation:** Whenever there is an outbreak of any disease in the campus or in the field practice area, students are involved in the investigation of the outbreak.
- **Family adoption program:** Students get to learn the socio cultural and environmental influence on the health of an individual. Students are encouraged to suggest corrective steps to improve the health of the family.
- **Patient centric and evidence based medicine:** Different medical conditions are discussed during bedside clinic. Along with subject, students are also taught about rights of patients, professional secrecy, respect for the patient, management of illness, professional ethics etc.

Marks are displayed on the notice board so that students can approach faculty if they have any grievances. Sessional marks are

uploaded in the MIS for parents to know the performance of their wards. Parents can meet the course coordinator or concerned Head of the department for any grievances related to the examinations.

**Theory examination:** University theory examination is automated with online transmission of question papers Theory examination halls are fitted with high definition CCTV cameras and theory examination centres are monitored by the university through web streaming. Answer scripts are scanned immediately after completion of the exam and are uploaded.

**Practical examination:** Marks obtained by the students in practical examination and viva-voce are uploaded after completion of the examination every day.

**Evaluation:** University has introduced digital evaluation of the theory answer scripts in 2016. Answer scripts are scanned

immediately after the completion of theory examination and made available for evaluation.

Formative examination/ evaluation of the students in the institution:

Continuous assessment of the students is done by, formative assessments (theory and practical), monthly tests, assignments, Viva voce, Practical record completion, Clinical postings (end posting tests). Students are allowed to interact with HOD or staff about their performance. Post-graduate residents are assessed by monthly or quarterly theory tests, Clinical/ practical examination, Log book entry with grading and yearly assessment by all staff of the department. - The laboratory is also equipped with most recent equipments like chemiluminescence, real-time PCR, five part haematology analyser, immunohistochemistry facility, immunofluorescence, fully automated biochemistry and hormone analysers

Healthcare Solutions Ltd (Common waste management facility approved by The Karnataka Pollution Board). The waste is transported in a covered vehicle to the treatment facility.

**Hazardous chemicals and radioactive waste management:**

Unused radioactive substances are handed over to the supplier for disposal. Hazardous chemicals are disposed as per Karnataka Biomedical Waste Management Rules and NABH guidelines.

Father Muller Medical College Hospital is accredited by National Accreditation Board for Hospital and Health care providers. Sessions on patient safety procedures and quality of care are conducted for undergraduate students before they start their clinical postings by the faculty of Hospital Infection Control Committee (HICC). HICC also conducts sessions on infection prevention and control practices for postgraduates and interns during orientation program. In addition to this, biannual training program on hospital infection prevention and control are conducted for students.

During the session students on Infection prevention for MBBS following topics are discussed:

- Hospital acquired infections.
- Hand hygiene.
- Personal Protective Equipment.
- Transmission based precautions.
- Needle stick injury.

Father Muller Medical College Hospital follows the guidelines laid down by the NABH about quality of care and patient safety procedures.

Students are educated about safety measures to be taken during examination and treatment of patients when they are posted to different clinical departments.

Students are given hands on training about patient care and safety procedures at Father Muller Simulation and Skills Centre.

Give a description of the instructional sessions for students introduced by the College on the Medical, Legal, Ethical and Social Issues involved in organ transplantation.

Organ donation saves lives. Making the decision to donate organs is the most important gift we can ever give. Students are made aware of various issues involved in organ transplantation during classes in Forensic Medicine and clinical postings. Medical and legal aspects of organ removal and transplantation are covered in Forensic Medicine class in MBBS Phase II as per The Transplantation of Human Organs Act, 1994. Provisions of the Act are discussed in detail. Along with the Act, ethical and social issues involved in organ donation and transplantation are also discussed. Medical aspects are discussed during clinical postings too. Fr Muller Medical college Hospital is authorized by the competent authority to carryout cornea transplantation and renal transplantation.

A session was organized in association with Indian Medical Association, Mangalore and AMC Trust, Mangalore for students about importance of organ donation on 22nd November 2018. Resource persons enlightened the students about what is organ donation, common

problem areas, Concerns about organ donation and how we have to encourage people for this noble cause. Around 400 students attended the talk also many of the students pledged for organ donation.

Describe the functioning of the Immunization Clinic in the Institution as per the quality specifications stated in WHO guidelines and the steps taken to provide students with information on its relevance and operational features within 100-200 words.

Immunization clinic is an integral part of Paediatric department. Immunization clinic is functioning everyday i.e. Monday to Saturday in this hospital. Ice lined Refrigerator (ILR) has been procured for the purpose of storing vaccines. Vaccines are stored in the ILR according to WHO guidelines. Quality maintenance is done periodically and records are maintained. Classes on immunization are taken for under graduate students. The classes include immunization schedule (both national and IAP vaccination). Details about individual vaccines are also taught. A class on newer vaccines is also included in the teaching schedule. Students are encouraged to observe immunization and are supposed to observe the storage of vaccination, how the vaccine is given, the route of administration and interact with the children.

Interns on their OPD days are actively involved in immunization / vaccination of children visiting the outpatient clinic. Interns also go to postnatal wards to help in giving BCG to the postnatal babies.

Academic calendar earmarks teaching and evaluation schedules for students to acquire clinical and surgical skills. Student centric learning is achieved through simulation based teaching, small group teaching, e-learning resources supported by ICT, research projects and outreach programs.

As the institution is affiliated to RGUHS, academic programs/ activities are conducted to meet the course outcomes prescribed by the University. Medical education is provided through well planned and executed academic process. Teaching schedule/ timetable is prepared taking into account the minimum number of hours for each subject as prescribed by the University. Classes are conducted as per the teaching schedule. In addition to the traditional method of teaching other methods of teaching-learning like simulation based learning, case based learning, bed side teaching, integrated teaching, community teaching are used.

Evaluation of the students for achievement of course and subject specific objectives is done by regular teaching - learning activities are meticulously planned in order to achieve the

objectives of under graduate and postgraduate curriculum. Dean, Head of departments and Course co-ordinators are involved in planning and implementation of teaching - learning programs.

- Curriculum Implementation Support Program: To train the faculty for effective implementation of the CBME curriculum. The concept of CBME, integration, and the newer elements of

the curriculum - the electives, foundation course, AETCOM module, early clinical exposure were discussed, as was assessment of competency-based education.

- Interns are trained in various aspects of professionalism.
- Workshops about medical education, faculty training etc.
