



The eligibility to undertake any particular DNB Final/Exit Examination will be determined strictly in accordance with the eligibility criteria laid down in the information bulletin for respective session.
- 4. NBE reserves its absolute right to take appropriate action including withdrawal of the candidates' registration and to recover damages against concerned hospital/withdrawal of accreditation if it is found that the candidate/Institution is not adhering to NBE guidelines / policies / directions and /or the terms of the instant Provisional Registration letter / letter of accreditation.

- 5. You are advised to read the latest Bulletin of Information carefully, when you apply for the DNB Final/Exit examinations especially, the eligibility criteria, schedule of examinations for better understanding of the Rules and Procedures in order to avoid rejection of application and forfeiture of examination fees.
- 6. Trainee(s) are also advised to quote the allotted Registration No. while applying for the Final/Exit examinations of NBE and also in all future correspondence of NBE. Registration number assigned to you is your unique identification number with NBE and has to be mentioned in all correspondence forthwith with NBE.
- 7. In order to avoid any delay in processing of any application for examination or thesis submission, the respective application forms are to be sent to this office duly filled in and signed/stamped by the competent forwarding authorities along with required documents as per prescribed information bulletin.

8. NBE Leave Rules:

- 8.1. DNB/FNB Trainees are entitled to avail leave during the course of DNB/FNB training as per the Leave Rules prescribed by NBE.
- 8.2. A DNB/FNB Trainees can avail a maximum of 30 days of leave in a year excluding regular duty off/ Gazetted holidays as per hospital/institute calendar/policy. This leave shall be processed at the institutional level.
- 8.3. Any kind of study leave is not permissible to DNB/FNB Trainees.
- 8.4. Under normal circumstances leave of one year should not be carried forward to the next year. However, in exceptional cases such as prolonged illness, the leave across the DNB/FNB training program may be clubbed together with prior approval of NBE.
- 8.5. Unauthorized absence from DNB/FNB training for more than 7 days may lead to cancellation of registration and discontinuation of the DNB/FNB training and rejoining shall not be permitted.
- 8.6. Any Leave availed by the candidate other than the eligible leave (30 days per year) shall lead to extension of DNB /FNB training. The training institute has to forward such requests to NBE along with the leave records of the candidate since his/her joining and supporting documents (if any) through the Head of the Institute with their recommendation/comments. NBE shall consider such requests on merit provided the seat is not carried over and compromise with training of existing trainees in the Department.
- 8.7. Any extension of DNB/FNB training beyond the scheduled completion date of training is permissible only under extra-ordinary circumstances with prior approval of NBE. Such extension is neither automatic nor shall be granted as a matter of routine.
- 8.8. DNB/FNB trainees are required to complete their training by a prescribed cutoff date (as per information bulletin of Exit exam) for being eligible to DNB/FNB Exit examination.
- 8.9. The eligibility for DNB/FNB Final Examination shall be determined strictly in accordance with the criteria prescribed in the respective information bulletin.
- 9. The concerned Heads of Accredited Hospitals/Institutes and DNB Program coordinators must ensure that the leave guidelines as prescribed by NBE are strictly adhered to; failure to comply these guidelines and sanctioning leave beyond purview of NBE leave norms may have an adverse impact on the renewal of accreditation.
